## Addresses

Report	Description
AM Correspondence Address with an end date	Correspondence address with an end date recorded against it. Ended addresses should not be used for correspondence.
AM Addresses with Manual Geocodes	Addresses where the Easting and Northings have been changed manually in the One system.
AM UPRN match but linked to wrong street	Address with a UPRN is not attached to a street with a USRN or the wrong street.
AM Duplicated Addresses	Duplicate addresses in One should be merged via Address Tidy or Address Merge.

Report	Description
AM Duplicate USRN and Postcode	This shows there are duplicated streets in the database.
AM Geocode address with NO LA number	A valid address but does not have an LA number against it.
AM Address with Phone Numbers	Addresses where an entity's phone number has been added to the Address incorrectly.
AM Addresses with no UPRN with USRN	Addresses that have no UPRN but have USRN for the street record.
AM Easting and Northing differences	The Eastings and or Northings in One do not match the AddressBase data.
AM Address history with no End or Start dates	Addresses where they have no end date against them, and they are not the correspondence address or addresses with no start dates.
AM One and AddressBase difference match on UPRN	Compare differences in address data between One and AddressBase where there is an exact match on UPRN.

Report	Description
ATT Duplicated Attendance Data	A duplicate string of Attendance data exists for child in the dx_xml_attendance table. A script is need from Capita to remove the incorrect string.
ATT Children registered at a base with no attendance in last 30 days	Children registered at a base but have not had attendance data imported against them at that registered base for over 30 days for the current academic year.
ATT Children with attendance data after the school history end date	Children where attendance data that has been recorded after the school history end date at the same school.
ATT Children with attendance data but not registered at a base	Children where attendance data is being recorded against a base that has not been ticked as Registered or Dual Registered and there is NO end date against the base.

SCH_HIST School ended but still registered	School history entries that are shown as dual or Main registered, yet they have an end date.
SCH_HIST Duplicated School History	Students with a duplicated School History entry based on Start Date End date and School all matching.
