# Introducing Our New Consultancy and Training Refresher for Free School Meals Claims

Transitional protection for free school meals was introduced in England on **1 April 2018**. This protection ensures that any pupil eligible for free school meals before this date, or who becomes eligible during the rollout of Universal Credit, will retain their eligibility until **31 March 2025** 

For our Grants and Benefits and FSM Portal customers it has been 7 years since claims had to be reviewed for eligibility periodically after applying. The knowledge of how to use the bulk checking and batch updating claims is possibly lost.

We are excited to announce the launch of our new consultancy and training workshop. This is designed to help you seamlessly adopt a new process for managing free school meals claims with and without Transition Protection.

You will need to start to differentiate between claims that retain their Transitional Protection until the child moves to another phase of education, and claims made after the 1<sup>st</sup> April 2025 that will need to be routinely rechecked. This means a new process and additional communication with parents and schools.

### Key Changes and Challenges:

- **New Process Adoption:** You will need to implement regular rechecking of claims, ensuring ongoing eligibility.
- **Increased Workload:** This change will result in an increase in administrative tasks and require more frequent communication with parents and schools.
- Enhanced Communication: Regular updates and clear communication channels will be essential to manage the new process effectively.


